



## **SAFETY RULES:**

All participants must conform to the following rules, to participate:

- All dogs must be licensed with collars/tags and be leashed (no flexi leashes).
- Leashes should not be any longer than 6 feet in length.
- Dogs must have a current license and be up to date with all vaccinations.
- A copy of rabies vaccination is required in order to participate – please bring this with you.
- Children under 18 must be accompanied by an adult.
- Dogs known to be aggressive with other dogs or people should not be brought to the walk.
- All walkers must have a pledge sheet and a signed "Waiver of Liability" to participate - see below.

## **WAIVER OF LIABILITY / ASSUMPTION OF ALL RISKS**

I, acknowledge that I have voluntarily applied to participate in [Dog Walk] "PROGRAM" with knowledge that it may involve numerous risks and dangers including, but limited to: acts of God; civil unrest; terrorism; use of roads, trails, hotels, vehicles, boats or other means of conveyance that are not operated nor maintained to customary and usual standards; high altitude; accident or illness without access to means of rapid evacuation or availability of medical supplies; the inadequacy of medical attention once provided; physical exertion for which I am not prepared; or negligence (but not willful, fraudulent or malicious conduct) on the part of [Sweetpea F.O.R. Animals Inc.] "SPONSOR". I fully understand, acknowledge and recognize that such risks and activity may be beyond the accepted safety and health standards of my life at home or work, yet they will contribute to my enjoyment and excitement and are a reason for my voluntary participation.

I AGREE TO BE RESPONSIBLE FOR MY OWN WELFARE, AND ACCEPT ANY AND ALL RISKS OF DELAY, UNANTICIPATED EVENTS, ILLNESS, INJURY, EMOTIONAL TRAUMA OR DEATH OF MYSELF, MY PET OR ALL MINORS PARTICIPATING WITH ME.

## **RELEASE**

In executing this Release of Liability and Assumption of All Risks and in consideration for being permitted to participate in the PROGRAM, I hereby RELEASE AND DISCHARGE SPONSOR AND ITS OFFICERS, DIRECTORS, EMPLOYEES, AGENTS, MEMBERS, STAFF AND ALL ORGANIZATIONS AND INDIVIDUALS ASSISTING IN PROMOTING, CONDUCTING OR OTHERWISE AFFILIATED WITH THE PROGRAM, AND EACH OF THEM FROM AND AGAINST ANY AND ALL LIABILITY ARISING FROM MY PARTICIPATION IN THE PROGRAM. I further agree this release shall be legally binding upon myself, all minors under the age of 21 participating with me, my heirs, successors, assigns, and legal representatives; it being my intention to fully assume all the risk of participation in the PROGRAM and to release SPONSOR from any and all liabilities to the maximum extent permitted by law.

I understand that my participation is contingent upon acceptance by SPONSOR.

I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.

## **KNOWING AND VOLUNTARY EXECUTION**

I have carefully read and fully understand the contents and legal ramifications of the safety rules and legal ramifications of this Agreement. I understand this is a legally binding and enforceable contract. I sign it of my own free will. If I had any questions or issues about this document, I have asked those questions and have been provided with complete information which was fully responsive and to my satisfaction.
